# Time Passes, and Activities Increase

The detailed list of the Federation's major activities in this appendix was prepared by Miss Esther Thornton, O.B.E., M.A., who was the Secretary or Secretary-General throughout the whole period. This rather formidable list obviously passes over many of the less spectacular activities, and the tremendous amount of correspondence and homework of the Secretariat. It does not deal with all the minor complications that arose, because they are common to all organisations; but in skimming through it, one gets some idea of the gradual growth of activity, from a newly founded body to a very large and active one. It gives a picture of the increasing number of member associations, which, of course, means the spread of interest, but it does not attempt to tell the story of the development of these associations.

This list catalogues the international meetings, the annual meetings, primarily held for members of member associations, and the congresses, which attract a larger group of participants. There are something over 40 of these international meetings, which we have held in many different countries. Vienna and Amsterdam are the only two places where we have held more than one annual meeting, and in both cases we had special reasons for so doing.

The annual meetings have always been held in cooperation with the local association or associations, and part of their objective has been to provide good and sensible publicity for their activities and to stir up interest in some field that concerned both.

This summary of activities covers the meetings of the Executive Board and of the Scientific Committee, neither of which is included in the figure quoted above for international meetings. Nevertheless, it is these meetings which have provided the power plant for the Federation.

In all, two regional meetings designed for a limited group of the officers of mental health societies have been held. These were not open meetings, any more than were the special conferences or meetings for an invited group of specialists. Like the special conferences and specialist meetings, they served a special purpose.

The summary does not give a picture of the close contacts the Federation has maintained with the UN and nongovernmental organisations (NGO's) which are pursuing similar goals to our own. For example, the Federation has been represented at all but two of the Health Assemblies of WHO since it came into being, and at quite a number of the annual meetings and the six regional committees of WHO. Theselike the arrangements for our own permanent representatives in New York, Geneva, and Paris-have meant a very real contribution to the work of the Federation, since the personal contacts established, the help given members of the UN Secretariats, and the chances of making suggestions to government delegates attending these meetings have done a great deal to establish the Federation, to earn considerable respect from the UN Secretariats, and to help change the climate of opinion about mental illness and mental health in many countries.

I have already noted that the Secretariat of the Economic and Social Council in New York invited the Federation to hold panel meetings on three occasions in the UN Headquarters. These meetings were attended by a considerable number of people—Secretariat personnel, members of delegations, and members of other international nongovernmental organisations.

The Federation has been called in on many occasions to help decide questions of policy, by WHO or by various sections of the UN itself, and this is not only an indication of official confidence in WFMH, but it gives us the opportunity of collaborating on the tasks for which we were founded.

There are two conferences referred to here which again were not attended by the general public. They were held for the benefit of high-level administrative personnel from the UN and the specialised agencies. The Carnegie Endowment for International Peace provided the necessary funds, but in large measure the Federation was responsible for their management and for the general line of discussion.

The specialised meetings held since 1950 have also had invited participants. Those marked with an asterisk have resulted in follow-up activities for which the groups themselves have been responsible. This means that the Federation was doing its job in activating the planning and the thoughts of people who attended. These special meetings, all of which have had publications and reports, were concerned with the following subjects:

Since the cessation of meetings held by the Interprofessional Advisory Committee (IPAC), a continuous series of meetings and small conferences has been called by the Scientific Committee of the Federation. Specially invited groups have attended.

The two teaching seminars—at Chichester in 1952 and in Manila in 1958—were both designed to help those in their own countries who teach others.

In addition to these special meetings, the Federation appointed a committee to conduct a series of lectures, as a memorial to Dr. Mary Hemingway Rees, on mental health and spiritual values. So far, four of these lectures have been given.

No listing is made of the many specialised conferences in which the Federation has taken its part at the request of UNESCO, WHO or some international nongovernmental organisation. There has actually been considerable activity during the years in the management of international conferences, sometimes small and specialised in their membership, but often much broader in appeal.

#### Visits

Elected members of the Executive Board travelling by air from all over the world have been in the habit of breaking their journeys to and from the place of meeting, to visit other countries as necessary. The Secretariat has been responsible for a great deal of the visiting, and over 70 countries have been visited in this manner.

#### Publications

At the request of UNESCO, WHO and other organisations, many special articles and some books have been published by the Federation. The various meetings called by the Federation have been reported in book form and have had a wide circulation.

# Manpower Loans

Finally, it might be noted that members of the Executive Board of the Federation have been invited to fill responsible posts in the mental health field—in WHO at Geneva, in Copenhagen (Regional Office for Europe), and at Alexandria (Eastern Mediterranean Regional Office).
